

Make-A-Song AGREEMENT

This is an agreement between (client's name) _____ (herein as "Client") and Angel Flower Music LLC (herein as "AFM") for the purchase of sound recordings offered thru the website of www.Make-A-Song.com
Client agrees to the following: (Check item that applies)

_____ Client is the sole author and rightful owner of submitted poems, lyrics, and /or music that is submitted to AFM for production. If submitted works have been created with other individuals, client has the legal permissions to proceed to enter into this contract and must be able to prove such in a court of law. THIS ITEM MUST BE CHECKED AND INITIALED.

_____ Package #1: AFM will provide a recording of a song in the Public Domain sung with client's new words. Client will maintain 100% ownership of client's lyrics. Melody remains in the Public Domain. This is considered a work for hire. AFM will not have any copyrights on such work. Price: \$20 to \$60 (\$20 first 3 minutes + \$10 per minute)

_____ Package #2: Recording of client's lyrics and melody. An appointment will be arranged for client or (designee of client) to sing client's song for taping so that a music accompaniment can be made. Client receives an MP3 of song with one instrument & a professional vocal, plus the instrument track. Client maintains 100% copyright of the music & lyrics. This is considered a work for hire. AFM will not have any copyrights on such work. *Recorded price: \$100

_____ Package #3: Recording of vocal with customized lyrics written to fit the music client has provided. Client will have opportunity to review and approve lyric prior to final recording. This is a collaboration and joint copyright between client and AFM. Client maintains 100% copyright of client's own music, AFM owns 100% copyright of lyrics. Fee is for recording of vox of AFM lyrics on client's existing music. Price: \$50

_____ Package #4: Recording of musical instrumentation and vocal with customized original lyrics written to fit the melody the client has provided. Client will have opportunity to review and approve lyric prior to final recording. This is a collaboration and joint copyright between client and AFM. Client owns 100% of client's own music, AFM owns 100% copyright of lyrics. Fee is for recorded musical arrangement and vox. *Recorded price: \$100

_____ Package #5: Recording of client's poem/lyrics sung to vocal melody with instrumentation. This includes crafting of poem into a lyric. Client will have opportunity to review and approve lyric prior to final recording. This is a collaboration and joint copyright between client and AFM. Client maintains 100% copyright of client's own poem/lyrics, AFM owns 100% copyright of music. Fee is for *recorded music & vox of client's poem/lyrics. Price: \$100

_____ Package #6: Your Jingle/Commercial: Custom 30 sec to 1 minute jingle. AFM retains copyright. *Recorded: call for pricing

_____ Package #7: A NEW SONG : New Melody Composed, New Lyrics written
Based on your theme/idea - 3 to 5 minute song. AFM retains copyright. *Recorded: call for pricing.

Payment can be made by Pay Pal or Credit Card via website. Terms: 50% upon contract, remaining 50% upon completion. Song will not be delivered until final payment is made. Songs can be previewed before final payment is made. Song will be delivered via MP3 via the internet. 2 CD's will be mailed for an additional charge of \$10 for handling and postage. Songs will be revised up to 3x per your requests. Your satisfaction is guaranteed or no fee is incurred. If a refund is requested it will be issued, however, this is a one-time benefit and will negate the possibility of future projects. You maintain all rights to your original works: lyrics, poems, melodies. AFM will not share your music, poems, lyrics, personal information or email address with third parties. Your project is completely confidential. AFM will protect your privacy and your artistic endeavors. New material, (lyrics/melody), are property of Angel Flower Music LLC and are copyright protected. All joint collaborations will be filed promptly by AFM with the US Library of Congress Copyright Office. Client and AFM are each required to pay 50% of joint filing fee, (\$17.50) as current price for filing is \$35. Multiple works will be submitted as a collection. Recordings are voice and one instrument only. Full orchestration and backup vocals are available at additional fees. Demo recordings are not necessarily broadcast quality. AFM does not promote, publish or promise any broadcasting of finished musical product via TV, radio, internet or satellite. Angel Flower Music LLC maintains the right to refuse any material, for any reason whatsoever. Make-A-Song.com is a part of Angel Flower Music LLC.
